RECOGNITION ORDER

Whereas, in terms of Section 14(1) of the NCTE Act, 1993, the **VBM EDUCATION TRUST, STREET\ROAD- VARUN PATH, MANSAROVAR, JAIPUR – 302020, RAJASTHAN** had submitted an application on **26.05.2016** to the Northern Regional Committee of the NCTE for grant of recognition/permission to **VAIDIK BALIKA PG MAHAVIDYALAYA, STREET\ROAD-VARUNPATH, MANSAROVAR, JAIPUR - 302020, RAJASTHAN** for **B.A.B.ED./B.SC.B.ED.- 4 YEAR INTEGRATED** course.

2. And whereas, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit, and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the WRC in its **324th meeting of WRC held on 23rd - 24th and 31st December 2020** is satisfied that the institution/society fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the **B.A.B.ED./B.SC.B.ED.- 4 YEARS INTEGRATED** programme, such as, infrastructural and instructional facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

3. Now therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993 and in accordance with the Regulations, 2014, the Western Regional Committee, (NCTE) hereby grants permission for conducting B.A.B.ED. course - 4 YEARS INTEGRATED course, with an annual intake of one unit of 50 students from the academic session 2021-2022 to VAIDIK BALIKA PG MAHAVIDYALAYA, STREET\ROAD-VARUNPATH, MANSAROVAR, JAIPUR - 302020, RAJASTHAN.

4. The institution is required to ensure about the availability of the regular staff for teaching **B.A.B.ED. - 4 YEARS INTEGRATED** courses.

5. The institution shall comply with various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

6. ~~The institution shall make admissions only after it obtains affiliation from the examining body in term of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.~~

7. ~~The institution shall ensure that the required number of academic staff for conducting the course is always in position.~~
